# PARAMOUNT UPDATES



**IN PAST ISSUES OF BACKSTAGE BULLETIN,** we've written about Theatre for Young Audiences and Stolp Island Theatre. These two projects are coming to fruition in 2024 and we're excited to share an update on their developments.

#### **STOLP ISLAND THEATRE**

Construction at Stolp Island Theatre, located at 5 E. Downer Place, is ongoing, and the theater is slated to open this summer. The theater will be Paramount's fourth venue – designed to provide an intimate atmosphere within a 98-seat theater that will transport you to a moment in time.

The first show to debut in the new space is *Million Dollar Quartet*. This new venture would not be possible without the support of our friends at Verano Zen Leaf and the City of Aurora. Subscriber pre-sale begins May 1. *Million Dollar Quartet* opens July 10.







#### **THEATRE FOR YOUNG AUDIENCES: BRIGHTER FUTURES**

In February, our Theatre for Young Audiences program kicked off a tour to local schools in Aurora. During this time, we visited five area schools where we staged nine free performances of the original work *Brighter Futures*, serving an estimated audience of 3,730 middle school and high school-aged students.

We learned from some of those schools that they have been on a "field trip halt" for the past few years, so this program is a particular treat for the students. One of the teachers said, "For many disadvantaged students, this program represents the only time they may ever see any live performances in their youth. Since Covid, most schools have allocated funds towards technology, and less and less towards the arts."

We're inspired to continue bringing performing arts to members of our community and help bridge this gap. Thank you to the National Endowment for the Arts, Aurora Women's Empowerment Foundation, and Waubonsee Community College for bringing this program to life.

## INFORMED CHARITABLE GIVING HOW TO MAKE THE MOST OUT OF YOUR GIVING DURING TAX SEASON

#### **IRA ROLLOVER**

Are you required to withdraw a minimum distribution from your individual retirement accounts? Starting in 2024, anyone who has an IRA and is 73 years or older is required to withdraw a minimum annual distribution (RMD). Eligible donors have until December 31 to make that withdrawal from their IRA – or until April 1 if it's your first RMD. If you fail to withdraw the full amount of the RMD by the due date, you run the risk of being subjected to a 50% excise tax.

Your RMD distributions are taxable, however there is a special exception which makes any money from an IRA that is paid directly to a qualified nonprofit – like Paramount – exempt from being taxed. This year, all individuals aged 70 ½ and older can donate up to \$105,000 to charity, tax-free, through Qualified Charitable Distributions (QCD) from their IRA funds. As a result, you, the donor, can avoid being pushed into a higher income tax bracket and optimize the tax benefits of giving.

We know that giving through an IRA is not an option for everyone, or that it may not be the right time for you personally, but we'd like to encourage you to start thinking about diversifying your charitable giving and planning for future tax seasons. Read on for other ways you can diversify your giving and maximize its benefits during tax season.

#### **DONATE APPRECIATED STOCK**

When you give through shares of stock directly to a qualified nonprofit, you avoid paying a capital gains tax at the time of the sale and the nonprofit benefits from getting the full market value of the stock. That means that you as a donor get the deduction on the full market value, which is a win for your tax bill.

#### **OTHER OPPORTUNITIES**

If you are getting ready to sell a business, real estate or other appreciated assets, you may also wish to make a charitable contribution to lessen or avoid the tax burden from that sale. Additionally, when you donate cash to a qualified 501c3 you can generally deduct up to 60% of your adjusted gross income to offset current tax year liabilities.

The options to make your mark through charitable giving and maximize your financial benefits are plentiful and we're happy to work with you to make sure you're getting the most out of your giving while supporting Paramount and our mission.
